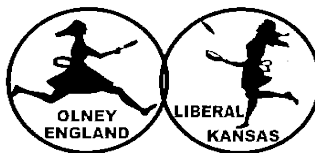

## INTERNATIONAL PANCAKE DAY COOKING/RECIPE CONTEST

### 2009 OFFICIAL RULES

**ELIGIBILITY:** The Pancake Day Cooking/Recipe Contest (the “Contest”) is open to anyone who resides in Liberal or within a 70 mile radius of Liberal and is within the age specifications for category listed. Members of the International Pancake Day of Liberal, Inc. Board of Directors, immediate family and household members are not eligible to participate.

**SPONSOR:** International Pancake Day of Liberal, Inc.

**AGREEMENT TO OFFICIAL RULES:** By participating in the Contest, each entrant unconditionally accepts these Official Rules and decisions of the Sponsor, which are final and binding.

**ENTRY TIMING:** The contestants will register in person at the Liberal Convention and Tourism Center at 1 Yellow Brick Road, Liberal, Kansas beginning on Tuesday, January 6, 2009 at 8:00 AM with registration ending on Friday, February 20, 2009 at 5 PM. A copy of the official rules and will be given to each contestant.

**JUDGING CRITERIA AND PROCESS:** Entries must be original, not previously published nor have won any other award. Each eligible, conforming entry will be evaluated using the following criteria, weighted on the basis of: Taste (40%), Originality/Creativity (25%), Use of product (25%) and Appetite Appeal (10%). ALL ENTRIES MUST BE BROUGHT TO THE KNIGHTS OF COLUMBUS HALL, 323 N. KANSAS AVE., LIBERAL, KS ON SATURDAY, FEBRUARY 21, 2009 FOR JUDGING. ALL ENTRIES MUST BE CHECKED BETWEEN 10:45-11:15 A.M. NO LATE ENTRIES WILL BE ACCEPTED. WHEN YOU TURN YOUR SELECTION IN, PLEASE INCLUDE WITH THE ENTRY THE COMPLETE RECIPE PRINTED OUT LEGIBLY ON AN INDEX CARD. DO NOT IDENTIFY YOUR ENTRY WITH YOUR NAME. YOU WILL BE ASSIGNED A NUMBER WHEN YOU REGISTER TO IDENTIFY YOUR ENTRY. ALL CONTESTANTS MUST REMAIN PRESENT FOR THE ENTIRETY OF THE JUDGING. ALL DECISIONS BY THE JUDGES ARE FINAL.

**REWARDS:** The winners of the contest will be recognized locally by various media and will be the guest of the Pancake Day Board of Directors at all of the event functions throughout Pancake Day 2009.

**REQUIREMENTS:**

- Name your recipe using words that describe it accurately. Do not use fanciful names that could infringe on trademarks.
- List all of the ingredients in the order they are used in the recipe. Use the exact measurements and package sizes of all ingredients.
- Write preparation directions in a clear and concise manner that is in complete sentences and paragraphs. Indicate the size of all pans, bowls or any preparation elements.
- Include every ingredient that you list in the directions.
- Indicate exact cooking times and temperatures. If appropriate, add suggestions as to when you can tell the dish has finished cooking.
- State the number of servings that the recipe is designated to create.
- Only one entry per person. All submissions will become the property of Sponsor, and none will be acknowledged or returned. Sponsor shall have the right to edit, adapt, and publish and all of the recipes submitted, and may use the recipes in any media without the attribution or compensation to the contestant, his or her successors or assigns, or any other party or entity. Submission of an entry in this contest constitutes entrant’s irrevocable assignment, conveyance and transference to the sponsor of all right, title and interest in the entry, including, without limitation, all copyrights. In addition, by entering, contestants represent and warrant that the recipes that they will submit:
  - Are their own original creations.
  - Do not infringe any other person’s or entity's rights.
  - Have not been submitted previously in a contest of any kind.

**PUBLICITY:** Except where prohibited, participation in the Contest constitutes winner's consent to Sponsor use of the winner's names, likeness, voice, opinions, biographical information, hometown and state for promotional purposes in any media without the further payment or consideration
